TOWARDS THE NEW YEAR 2010

Dear Comrades,

CHQ wishes a happy and prosperous new year 2010 to all our members and well wishers. Let the New Year be a year full of activities to promote and defend the interests of the common people and the toiling masses.

Wage Revision: - Wage Negotiation is in the last stage. There are some more issues to be sorted out like span of the scale, uniform etc. The management is very particular to abolish the uniform and connected allowances which we cannot agree at all. We want the span of scales to be increased, which they are very reluctant to agree. We hope to sort out the issue before the next meeting on 5th January 2010. The meeting fixed for 29th December, 2009 had to be postponed since most of the official members are either on training or on leave. We want to finalise the agreement by 5th January, 2010 itself.

Anomaly Report: - The report has been finalised with the agreement that the difference of less amount than the junior in the junior grade will be sorted out by granting personal pay to the senior in the higher grade, since the DOT has not agreed to approve the earlier agreement stating that the issue can not be settled under FR or by the provisions of the Revised Pay Rules. The agreement will now go to Management Committee and then to BSNL Board after approval of which the necessary orders will be issued. This issue need not go to DOT for approval. CHQ is trying for getting early orders.

Promotion Policy: - General Secretary is trying to meet the Secretary, DOT to get the approval for promotion policy. In case it is to be sent for DPE, then we have already demanded the management to implement the policy without prejudice to the 9200 scale being approved.

CEC Meeting: - The next Central Executive Committee Meeting is decided to be held at Bhopal (M.P) from 14th to 16th February 2010. CEC members are requested to book the tickers early to ensure reservation. The notice has already been issued as also published in the Telemessage January 2010.

All India Conference: - The Fifth All India Conference of BSNLEU will be held at Thiruvananthapuram by the first-second week of May 2010. Reception Committee will be formed shortly. District and Circle Conferences which are due should be conducted without delay. The number of delegates eligible will be intimated on the basis of the CHQ quota received in 2008 and 2009.

Membership Campaign: - CHQ hopes that serious effort and campaign have already been started by the Circle/District/Branches to enrol maximum members during the one month, 16th December to 15th January 2010. Maximum effort may be made in this respect.

A I B D P A: - Circle/District Secretaries are requested to take initiative in firming the Circle and District Branches of the recently formed All India BSNL DOT Pensioners Association(AIBDPA). District and Circle Conventions be organised for this purpose without delay.

Confederation of Central Govt. Employees and Workers: - 23rd National Council of Central Govt. Employees and workers was held at New Delhi from 4th to 6th December 2009 presided over by Com. K.Vyas, President. Com.V.A.N.Namboodiri, General Secretary, BSNLEU addressed the delegate session on 5th December and conveyed the greetings of the BSNL workers. He also mentioned about the issues of the BSNL Pensioners on 50% merger of IDA, Pension revision etc. which require urgent settlement. Coms. S.K.Vyas and K.K.N.Kutty have been re-elected as President and Secretary General respectively.
